Landscaping

The Board reviewed the tree work at the community.

Upon a motion duly made, seconded, and unanimously carried, the Board approved \$855.00 for carpet roses and mulch in the planters by the front entrance to be paid from Reserves. (Denlinger/Armstrong)

Facilities/Maintenance

Mr. Hebert reviewed the Maintenance report as prepared.

Mr. Hebert reported that the Architectural Committee asked the Board to add a peaked structure to the north trellis similar to the south trellis. Big Build Construction quote is \$3,845.00. A new ARC request would be required. More information will be reviewed at the next meeting.

We received the light samples, and it was agreed to keep looking at other options.

Court Tech started replacement on fencing and windscreens on courts 2 and 3. Mr. Herbert reported that only half of the fencing needed was delivered and remainder of delivery will take a few more days. Mr. Hebert reported that the contract regarding the design of fence needs to be resolved with Court Tech ASAP.

It was decided to wait until fall to drain and acid wash the pool. Also a few coping stones have come off and need to be reinstalled and Mr. Hebert will ask the pool company to adhere them prior to draining the pool.

There is no update from Lloyd Termite.

Mrs. Lloret was not present. The Board discussed the host for the July Happy Hour. It was agreed to have a staff member be present at the July Happy Hour.
