Therefore, the Board asked Management to hire their own Arborist to provide a second opinion.

**Arborist bid** – The Board asked Management to negotiate with Greenbrier to see if they would be willing to provide their arborist report at no charge if we approve all their tree trimming bids.

**Updated Reserve Study –** Management provided the updated Reserve Study for the Boards review.

**Bid to install landscape along 17679 Adena Lane** – Upon a motion made, seconded, and carried, it was; **RESOLVED**; to approve the bid from LandscapesUSA in the amount of \$2,063.80 to install new plants and grass along the side of 17679 Adena Lane.
